- Being reliable






Important information

Will I get paid?

You will get paid £20 per hour £140 for every day you work (up to 7.5 hours)

Will I have to work every day?



This is a sessional job, this means you work when you are needed. This is **NOT** a full time or part time job. You might work one or two days each month. Some months you might not work at all.

If you receive benefits you need to check if earning money will affect them and decide if you are happy with this.

Where will I work?

The Shared Lives Plus office is in Liverpool so we might meet in Liverpool or other towns to work together. We will help you to organise your travel and to get support to travel if you need it. We will pay your



Do I have to live in England to do the job?

You can live anywhere in England, Scotland, Wales or Northern Ireland to do the job but need to be able to travel (with support if you need it).



What support will I get?

You will get training to help you be a Shared Lives Ambassador. Sometimes you will work as a big team, sometimes in a small team or sometimes you might work on your own supported by staff from Shared Lives Plus.

What support will I get?

We can get help for you to become self-employed so you do your own tax and national insurance, or we can put you on our payroll (so we do all your tax).

We can get help for you to apply to Access to Work for any support you need to travel, do your job or for equipment.
